The U.S. Coast Guard does not provide direct appropriated or non-appropriated funds to support most Auxiliary missions. Funding is provided by the Association through membership dues, sale of educational course & products, sales of other materials, grants, and other miscellaneous income sources.

Check List for enrolling an Associate Member

Follow instruction sheet received by FC with initial supply of 10 envelope/application forms, 5 brochures & reorder form.

Envelope/application forms & brochures are NOT to be used as general handouts for booths or other public events. Use only with truly interested supporters.

Identify potential Associate Members through PE classes (if student doesn't join USCGAux), VSC participants, Assisted Mariners, local marine suppliers/clubs, friends, acquaintances, co-workers, etc.

Print flotilla number, e.g. 092-01-01, & recruiter's member number in space provided on envelope's inside flap. Flotilla receives 40% of initial contribution for new Associate Members they enroll.

Annual renewals handled automatically by Association.

Assist applicant with completing all information on the envelope.

Tear off application flap, insert into envelope with contribution.

Seal envelope & mail it—No Postage Required.

Thank applicant for joining the Association and for supporting the volunteers of the U.S. Coast Guard Auxiliary.

Re-order forms as needed and prescribed in the instruction sheet received by the FC.

Membership may be individual for contributions of \$25—\$25,000

Corporate Memberships available for contributions of \$1,000—\$25,000.
